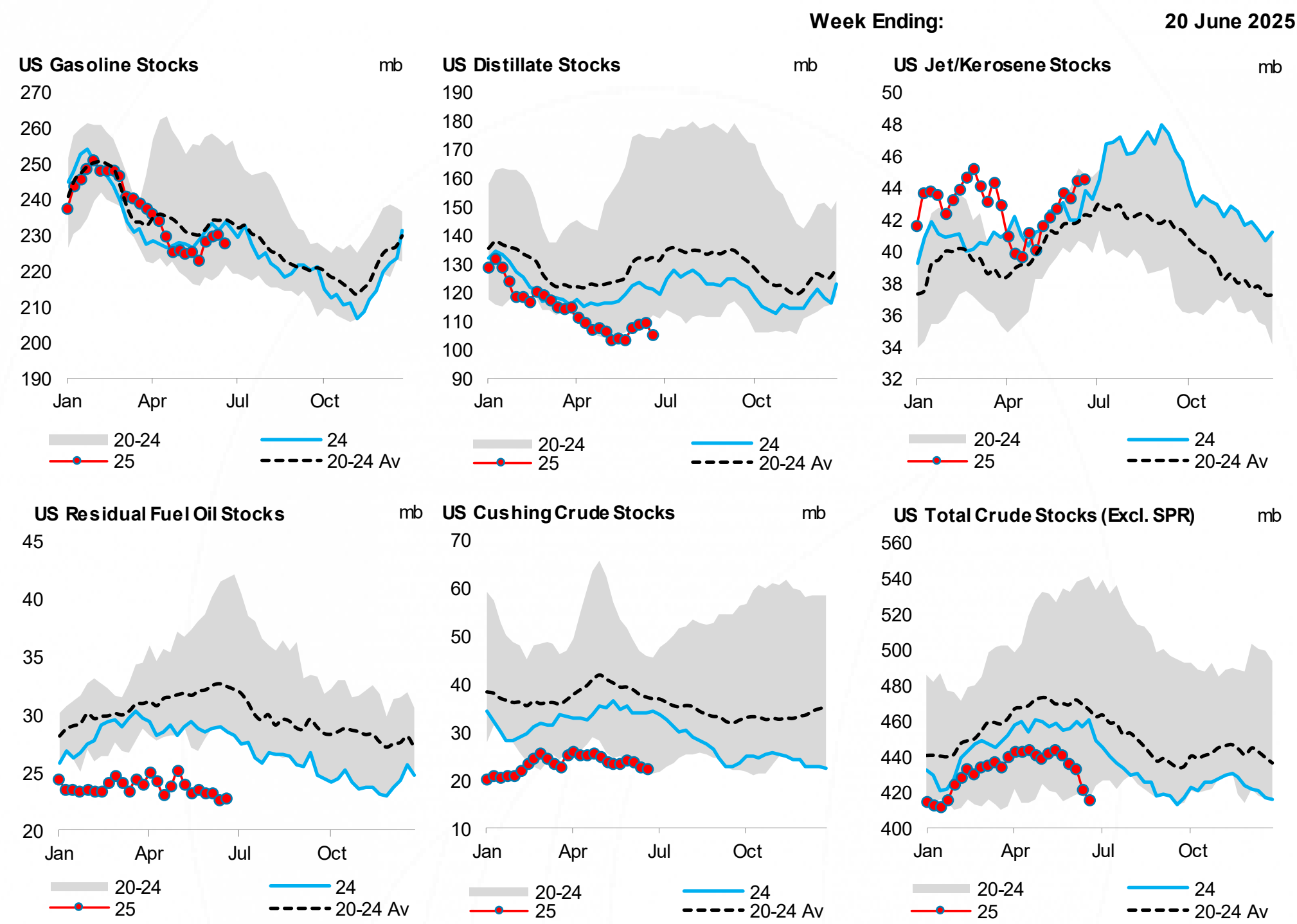

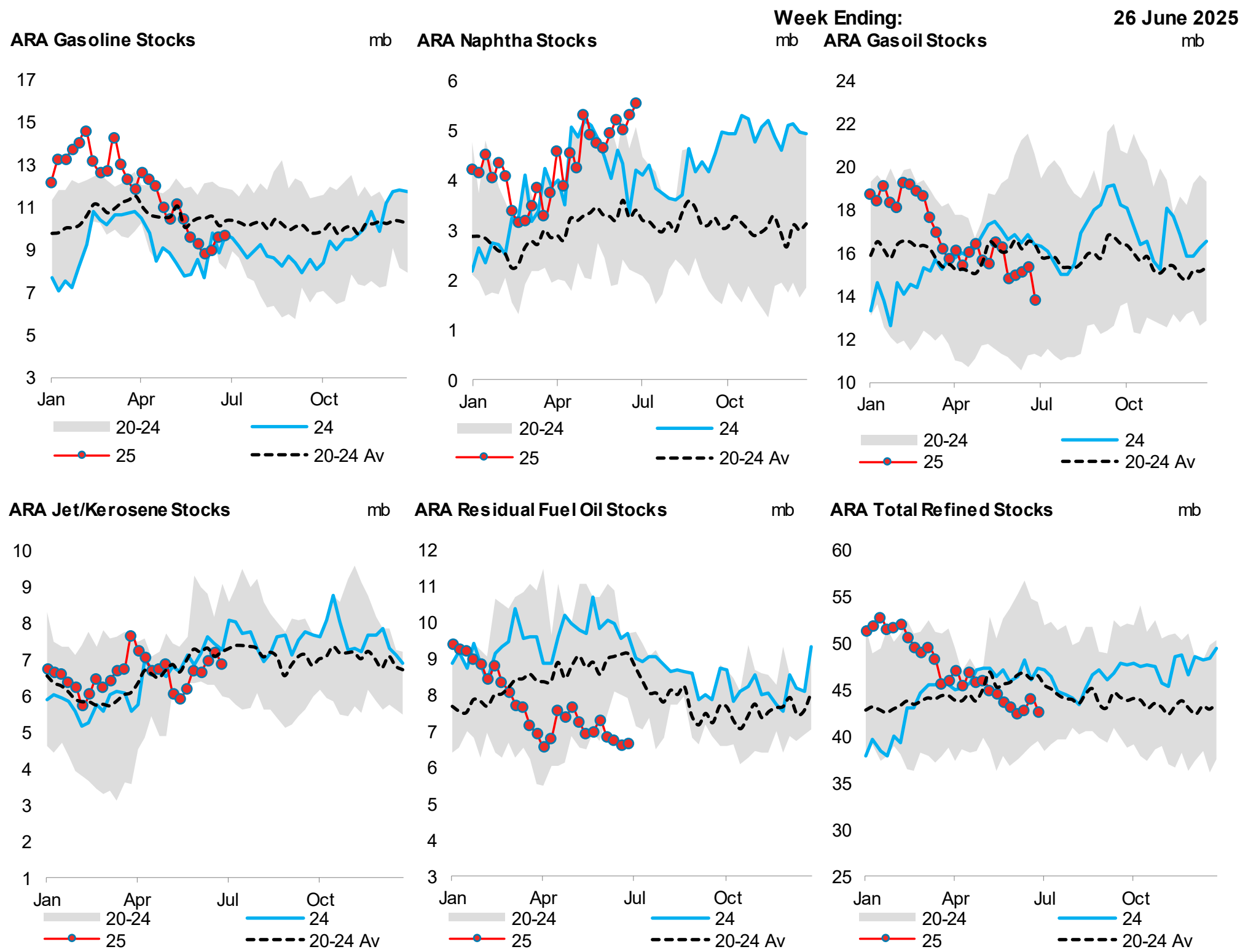
Fig.1 – US EIA crude and product stocks (million barrels)

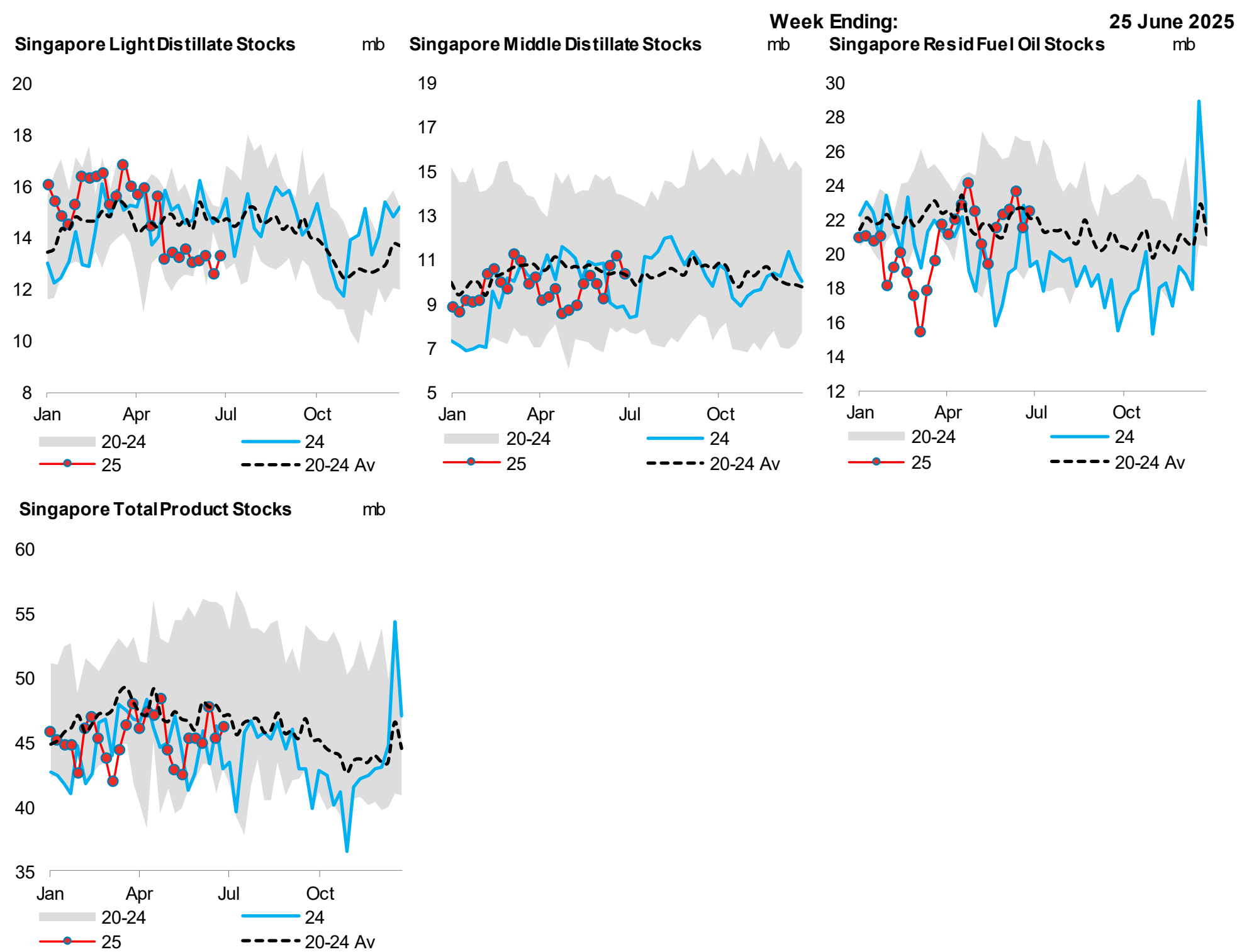
Fig.2 – Weekly ARA independent storage of oil product stocks (million barrels)

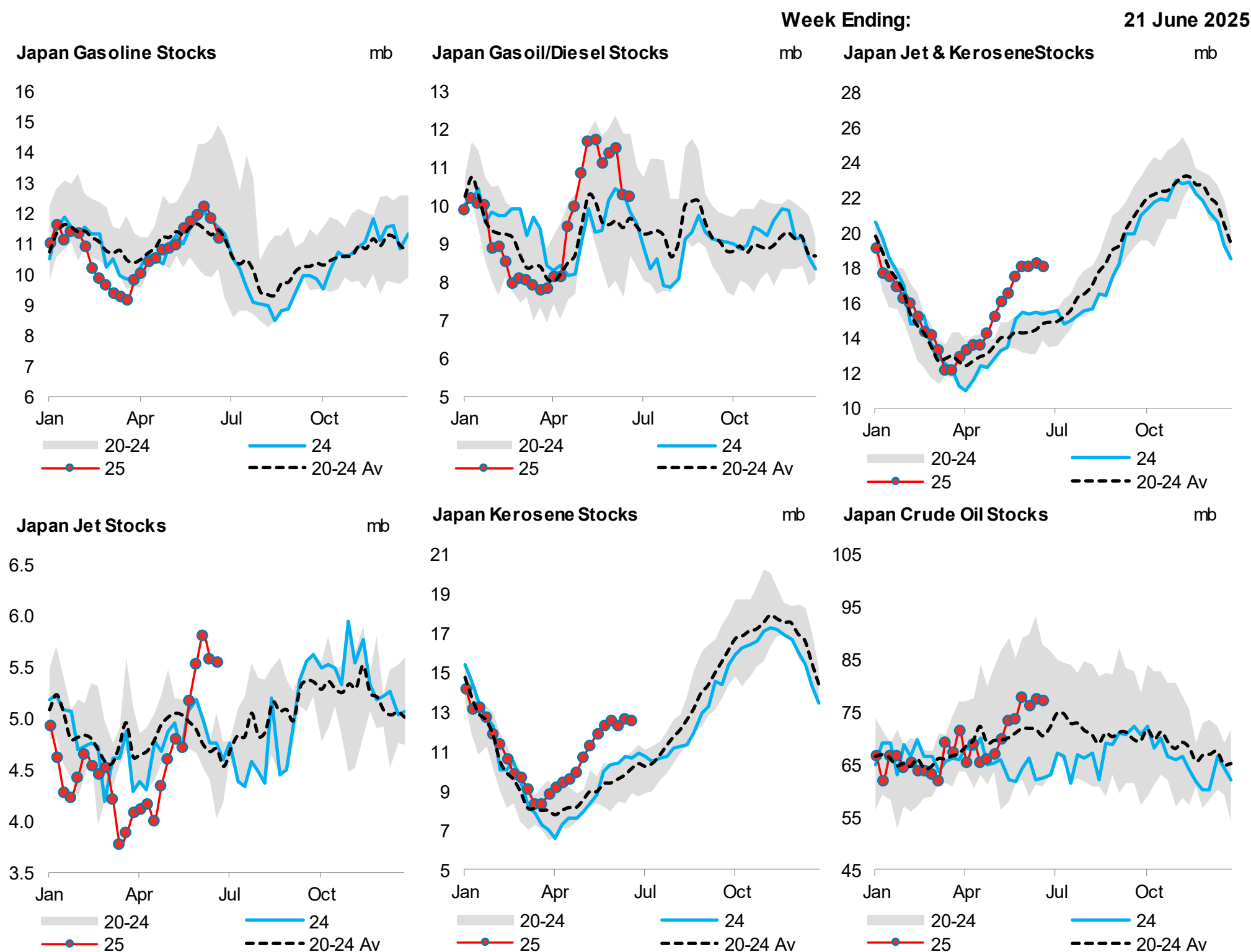
Fig.3 – Weekly Singapore oil product stocks (million barrels)
