Fig.2 – Energy correlation in daily returns, Energy futures vs DXY Index







Fig.2 – Energy correlation in daily returns, Energy futures vs S&P 500 Index

Fig.3 – Energy correlation in daily returns, Energy futures vs US 10-year yield







Fig.4 – Energy correlation in daily returns, Energy futures vs Bloomberg BTC Index
